# Treasurer's Report

The accounts for the 20/21 year show us in a healthy position as shown on the Balance Sheet and Profit and Loss reports. A combination of grants, discounts, membership and fewer expenses has meant that our account balance in the past year has had a negligible increase. As per last year, we're still missing fundraising as a revenue stream.

Our affiliation fee with Australian Sailing went to the next band (19) this year, due to our member numbers growing. So our standard fee will be \$2,000 per year. We received a discount due to the current pandemic, with the actual fee being \$1,800. Last year we were on band 20 with an annual fee of \$1,527, which was then discounted by 50% again due to the pandemic.

With thanks to Peter Ross for organising, we received a grant of \$750 from the NSW Office of Sport through their local sports grant program in June.

In July last year, Australian Sailing contributed \$1,000 for fixed costs, through the NSW Community Sport Recovery Grassroots Sports Fund Application. Again, this was organised by Peter Ross.
